Overview of Bullying:

The Safe and Drug-Free Schools and Communities Act of the No Child Left Behind Act of 2001 was enacted to provide federal support to promote school safety. When instated, however, the act omitted any reference to bullying. Therefore, H. R. 284 was created to address the issue of bullying.

Definition of Bullying:

Bullying is defined by H.R. 284 as conduct that is based on a student's actual or perceived identity with regard to race, color, national origin, gender, disability, sexual orientation, religion, or any other distinguishing characteristics that may be defined by a State or local educational agency, that is directed at one or more students; substantially interferes with educational opportunities or educational programs of such students; and adversely affects the ability of a student to participate in or benefit from the school's educational programs or activities by placing a student in reasonable fear of physical harm. A student is being bullied, according to Safe and Responsive Schools when exposed, repeatedly over time, to intentional injury or discomfort inflicted by one or more other students. Bullying behavior may include physical contact, verbal assault, making obscene gestures or facial expressions, and being intentionally excluded. Bullying implies an imbalance in power or strength in which one child is victimized by others. Safe and Responsive Schools emphasizes that bullying is a serious threat that may have detrimental psychological effects on children such as low self-esteem, depression, and suicide.
